

# Hygiene and safety measures regarding the Double-Disc-Court-Event „European Open Berlin“, organized by the „Berlin Frisbeesport Verband“ on 27. of September 2020 (version: 28.08.2020)

## Responsibilities

- Responsible for the organization of the tournament are: the tournament director: Gregor Marter. Responsible for hygiene and safety measures is Malte Berghäll – in particular this person is responsible for this concept, the path-concept and the coordination of the usage of sanitary facilities.

## General informations

- The foundations of this concept are:

- surface disinfectant, hand sanitizer, liquid soap, paper towels, disposable gloves and face masks are available in sufficient amounts.
- Any rules and measures regarding hygiene and safety for the event are distributed to the participants, if applicable their parents (for participants below the age of 16) and persons responsible at the *Berlin Frisbeesportverband* via e-mail or postings. With a signature on the declaration of consent (see below), a participant declares to agree to the rules, that are stated in this document.
- There is a bound on 30 participants (including the organizers) for this event. The tournament director is responsible for the abidance by this bound.
- The tournament director is responsible for opening and closing the venue before/after each day of the event.
- Any remaining questions/problems by participants or, if applicable, their

parents shall be solved via e-mail (to: anthraxium {at} gmx {dot} de).

- The event is scheduled as follows: Sunday, 27 of September 2020, 10:00-17:00, Friedrich-Ludwig-Jahn-Sportpark (Coordinates: 52.545066, 13.407519)

### Rulings regarding the geography of the venue

- Every participant has to abide to the “path-concept” (for each day), which is linked to this document.
- Every participant enters the venue shortly before the start of the tournament. Furthermore, every participant has to leave the venue shortly after the end of the tournament day, without anyone staying longer than necessary.
- The participants are required to wear their face-masks at any times on the venue during the tournament with exception of: (a) the physical activity on the sport fields (b) the usage of the showers and changing rooms after the tournament day (coordinated by the person responsible for hygiene and safety measures). In particular, one has to wear the face-mask in the break-area (see path-concept) where participants and guests are required to abide by a distancing regulation of 1.5 meters. Every participant/guest is given a fixed resting place in the break-area that abides by the distancing regulation.
- In particular, every participant has to wear a face-mask while using the sanitary facilities and may only remove the mask, if he leaves the facilities. Of course this does not apply to the usage of the changing rooms and showers at the end of a tournament day.
- Only two people are allowed to use the sanitary facilities at the same time.
- The organizers are responsible for a sufficient distribution of the path concept and the safety and hygiene measures at the venue.

### First-Aid

- A first-aid-kit is located at the sanitary facilities. Additional disposable gloves and face-masks are added to the kit.
- If possible, injuries are treated outside of the sanitary facilities due to hygiene and safety reasons.

## Responsibilities regarding the participants

- Every participant (if applicable, their parents) has to sign the declaration of consent. Thereby it is understood, that they have read and are willing to abide to the hygiene and safety measures as well as the current version of the hygiene and safety measures for the *Bundesland Berlin*. Any participant has to be listed in a list of participants, administered by the tournament director. This list of participants (see below) shall contain all the necessary data to guarantee the traceability (name, address, Tel.).
- If a participant refuses to give particulars, that are necessary for the list of participants or deliberately give particulars, that turn out to be false, the tournament director is given the right to instruct them to leave the venue.
- If the tournament organizers, participants or guests show any signs of disease, they are prohibited from entering the venue.
- Any participant/organizer/guests have to meet the following criteria to be able to part-take in the event (self-reporting):
  - He/She had no health restrictions/disease symptoms within the last 14 days.
  - He/she hadn't had any contact to a person, who had been diagnosed with a coronavirus-infection within the last 14 days.
  - If one has resided in a “risk-area”: He/She can provide evidence of a negative corona-test-result, that was taken no more than 48 hours before entering Germany (see below).
  - Every participant has to bring their own face-mask – and if necessary their own disposable gloves – with them to the venue.
- Every participant/guest has to abide by the orders of the tournament organizers. If anyone is spotted acting against the measures and rulings the are either written or referred to in this document, the tournament director has the opportunity to ban him from the event and the venue. In this case, they will have to leave the venue directly and in abidance by the path-concept.
- On time, at the beginning of the tournament day, participants meet up at the entrance to the venue (see path-concept), abiding by the distancing regulations. Everyone has to put on her/his face-mask before entering. The tournament director admits the participants into the venue and

secures the abidance by the hygiene and safety measures.

- Participants arriving to the venue by bike, are asked to take their bikes with them to their resting place, so that crowding around the bike stands can be prevented.  
Furthermore, the participants are asked to plan their arrival without the usage of shared rides.
- Should it be the case, that authorities (the *Berlin Ordnungsamt*) take notice of violations against any rulings, that were referred to or explicitly stated in this document by participants during the event, these participants agree to taking full responsibility for their actions and face the legal consequences with the act of signing the letter of agreement below.
- The materials necessary for the tournament (discs and lines) are in private ownership of the participants – Thus the owners themselves are responsible for their disinfection before and after every tournament day. Therefore, the person responsible for the hygiene and safety measures has to organize stations for disinfection (marked in the path-concept).
- The participants arrive to the venue in sportswear. Solely the shoes may be changed at the venue.
- Children under the age of 12 may not participate at the event. An exception is given in the case of parents/a parent of an under 12 year-old participating at the event: If it isn't possible in any other way, they can take their children with them to the event. Consequently, parents are responsible for their children with respect to an abidance by the current hygiene and safety measures.
- Only if it is necessary, parents/assistants may have access to the venue as well. They are required to stay at their resting place in the break area, abiding by the distancing regulations.
- For participants, that have not reached the age of discretion (between the age of 12 and 16), their parents are required to sign the declaration of consent below. Thusly, their parents are held responsible for any offence against the measures, committed by their children.

### Face-masks

- On the sport field and during the games, there is no requirement to wear a face-mask. But the mask has to be in reach, if an injury of any participant occurs, that makes first aid by the participants necessary

(and in this case, they're required to put on their masks).

- In the break-area (see path-concept) there is no requirement during food-consumption, whilst a 3 meter distancing regulation applies.
- In any situation, that is not explicitly stated here, everyone is required to wear their mask!

### Physical contact

- Double Disc Court necessarily involves physical contact between two players, which are in fixed teams during the whole tournament. Thus the usual distancing regulation of 1.5 metres doesn't apply during the games within those fixed teams.
- Between two single fields, wherein the fixed teams play, there has to be a minimum distance of 3 metres.
- With the exception of an injury that requires first-aid measures, physical contact has to be refrained from in any other given situation at the tournament. The distancing regulation of 3 metres applies in those situations. In particular the participants shall refrain from shaking hands/giving high-fives/...

### During the tournament

- There are stations for disinfectant, marked in the path-concept. Participants/Guests are required to use them after/before every game and before any food consumption. The Robert-Koch-Institute gives the following advice regarding the process of disinfection:

- The person responsible for the hygiene and safety measures is responsible for the organization of said stations for disinfectant.
- Every participant is required to bring her/his own bottle of water with her/him. If possible, her/his name should be written on it. There is an option to refill them at the sanitary facilities. Furthermore, one is asked to bring a towel for any warm-up exercises on the ground.
- The tournament director administers the list of participants. Thus he is required to abide by the current data protection regulations. If any participant is diagnosed with the virus within 14 days after the event, the director is required to pass the list to the public health department. Otherwise, there is an obligation to preserve the list for 4 weeks after

the event – After this, he has to destroy the data.

### On the usage of sanitary facilities

- The person responsible for the hygiene and safety measures is responsible for the design of a path concept within the facilities. In addition, he coordinates any partition of the facilities (if needed) amongst participants of this event and other events that take place at the same time and need access to the facilities as well.
- Except for the case of a medical emergency, that makes entering them immediately necessary, the participants shall only enter the sanitary facilities after telling the person responsible for the hygiene and safety measures. After usage, the participants are required to leave them directly (in accordance with the path-concept). Lastly, It should be said that participants are solely allowed to use those sanitary facilities during the event, that are identified by the tournament organizers (and thereby shown in the path-concept).
- Only one person is allowed per toilet. Children below the age of six pose an exception to that rule; Their parents can accompany them.
- Participants arrive at the venue in their sports clothing. Solely a single usage of the changing rooms and the showers is allowed at the end of each tournament day. The following measures apply in this case:
  - Following the tournament schedule, the person responsible for the hygiene and safety measures is required to set up a showering-plan for the participants. In each changing room + shower available (1 male, 1 female) there are 2 people allowed at the same time.
  - Only within those fixed slots, set up in the plan, that is distributed for everyone to see, the participants are allowed to use the showers and changing rooms.
- At last, the person responsible for the hygiene and safety measures is also responsible for opening and closing the sanitary facilities. Furthermore he is responsible for indicating any necessary divisions of the facilities. The participants themselves are responsible for leaving the facilities clean.

### Informations for participants, arriving from “risk-areas”

This list is frequently updated and it will apply in the exact version for

the event (26./27. of September 2020).

- People, arriving from these areas are only allowed to the event, if they can provide evidence of a negative corona-test-result, that was taken no more than 48 hours before entering Germany.
- For further informations/recommendations: See the website above.
- At last, participants that do not arrive from these “risk-areas” may participate at the event as soon as they have signed the declaration of consent and are registered in the list of participants.

### Informations for guests

- Over the course of the tournament day, at most 100 guests are allowed to the venue. The tournament director is responsible for organizing an attendance sheet at the entrance to the venue.
- Furthermore, guests are given a fixed resting place, as long as the remaining area suffices (10 square metres per person) – If there is not enough space remaining, there are no more guests allowed to the venue.
- If guests act against the hygiene and safety measures (stated or referred to in this document), the tournament director is responsible for banning those people from the venue.
